Clerks' Remarks and Query

Referring to our business meeting as "Meeting for Worship with attention to business", 1) What are we seeking to accomplish? 2) How does saying it this way affect our participation?

- A Friend spoke to the practice of eldering, and holding the Meeting, our clerk, AND the self, as part of participating in Meeting, not a separate practice.
- We are here not just for the Meeting's business, not just our business, but to a greater sense of something we are part of. We make ourselves available for what is unknown.
 - To be in the place of non-knowing opens up a profound curiosity.
- The mind of not-knowing is a Buddhist practice. It is liberating to not know, that that can be an accepted and even a celebrated thing. It makes this less an administrative meeting and more of a spiritual practice, or at least an integrated practice.
- Divine order you might not get what you ordered! That leaves the divine, and then we can discern is this divine, or not?

It was suggested that we have an in-person meeting next week, regardless of our ability to do a hybrid meeting with Zoom, so that Collen can attend. And, perhaps it is not a good time to try to meet in person due to the Omicron variant of Covid. It was suggested that it is an individual decision to attend. AFSC Is at a Perilous Crossroads

We write as concerned Quakers and friends of Friends about a dramatic re-engineering of the organizational structure of AFSC proposed by management and Board leadership that will alter the Quaker character of the organization. Despite widespread dissent among staff and governance members, management has continued

to push this plan forward. We write this public article because we love AFSC and feel the vocal uneasiness expressed has not been heard inside the organization. We call on other Quakers to call for a cessation of the planned restructure, an external evaluation of the Senior Leadership Team and a searching, well facilitated internal conversation about how this process proceeded so far despite widespread opposition and how the organization can heal and move forward collectively, honoring all voices especially those most impacted by the issues upon which AFSC focuses. The People's AFSC - Survey Results Executive Summary

Introduction

The People's AFSC, a volunteer collective of AFSC staff and governance members, sent out a survey in English, Spanish and Bahasa on April 23; the available translations were expanded shortly after to include Arabic, Khmer, Burmese, and French. Survey responses were collected until 9am EST on May 10, 2021. The People's AFSC developed this survey to better understand how AFSC staff and governance members feel about the current AFSC restructuring process and its implementation by the Leadership Team. Also included in the survey were questions about respondents' current morale and opinions about the vision and requests presented by the People's AFSC.

The survey received 149 responses. Below you will find:

To the editors:



We are writing in response to the recent article published by Western Friend on Friday, December 18, which outlined concerns about the American Friends Service Committee's restructuring process. [See: https://westernfriend.org/media/afsc-perilous-crossroads]

We believe that all members of the AFSC community are motivated by deep love for and commitment to AFSC and the communities with whom we work. That said, there are many diverse voices to attend to within the AFSC community. The fundamental question is about how best to organize ourselves to

advance our recently established strategic goals—and a passionate discussion is alive at AFSC on just those issues. Disagreements are to be expected, and good faith dialogue on the substance is welcome.

We want to take this opportunity to set the record straight on some of the issues raised in the article and to encourage continued dialogue on how AFSC can participate in building a more just and peaceful world.

Powering Up the Next Generation: In comic books, heroes have gripping, adventurous origin stories: exposure to some radical experiment; strange rays from outer space; the loss of a loved one, spurring our would-be hero into action. A *nom de guerre* is assumed; a costume is donned; and a hero is born.

Quakers don't like the term. It smacks of hubris, of pulp fiction, of self-righteousness. Popular culture is full of clichés about heroes. Heroes are born, not made. When the time is right, a hero will emerge. Everyone is the hero in their own story. Harper Lee's Atticus Finch said that courage is shown When someone gets up when he's knocked down and fights for what's right, even if he knows he's licked before he ever starts.


