# **MINUTES AND RECORD:** Meeting for Worship on the Occasion of Business, February 18, 2024

We met in a hybrid meeting in person at the meetinghouse and on Zoom.

**Present:** Dorothy Henderson (clerk), Doug Hamm, Chamba Cooke, Amy Cooke (co-recording clerk), Sharon Davisson, Judy Hamilton, Reed Hamilton, Gordon Starr, Mary Starr, Dianne Marshall, Peter O'Rourke.

The Meeting opened with silent worship.

#### **Clerks' Remarks and Query:**

Dorothy introduced the Clerk's Table: Dorothy Henderson, presiding clerk; Amy Cooke, recording clerk; Gordon Starr, elder to the clerk; and Mary Starr, Zoom assistant.

Remarks and Query: Dorothy spoke of watching the Super Bowl ads. One ad is silent, depicting people washing each other's feet. The message was that Jesus did not teach hate.

How do we, in this Meeting, wash each other's feet?

Dorothy was inspired to share a quotation from the book, *On Listening to Another* by Douglas Steere. She noted that we listen to each other in what can be a transformative way.

Dorothy asked Friends to respond out of worship.

There was a message shared of being deeply touched, of sharing Happy Valentine's Day wishes with strangers, of how kindness and connection raises us all up. Another Friend shared about the Waking Up group that meets under the care of the Meeting. The deep listening that the Friend experienced in that group inspired her to join the Meeting. A Friend shared about her high school experience of listening deeply to a friend while participating in the American Friends Service Committee, an experience that taught her about empathy - oh, and she married that friend 30 years later! Spirit and Witness meetings are a place one Friend feels both deeply heard and able to share openly. A committee of care gives another Friend the experience of pure listening without boundaries. Examples rose up of the times when a Friend did not listen, or was not heard. A time when a friend reflected in the middle of a sharing, "You're an idiot!" have her a sense of being seen and heard through the authenticity of humor and connection.

It was noted in the committee that the Directory Clerk does not have a home in a committee. They recommend that the Directory Clerk be held in the Welcome Committee.

**Proposed Minute** (to be seasoned until 03.2024): Grass Valley Friends Meeting accepts the nomination of Gordon Starr and Don McCormick for the positions of co-Recorder/Archivist to serve for the remaining portion the 2023-2024 year.

It was requested that if items are selected by the co-Recorders/Archivists to be discarded that others in the meeting be notified.

A Friend reminded us that we had the idea of forming a task force for best practices to manage the paper and digital archives of the Meeting. A suggestion was made to form the task force to help with discernment on what to discard and what to keep, and how to keep those records, whether digital or paper. This task force could assist the co-Recorders/Archivists.

It was noted that the Meeting records have been neglected. A suggestion was made that the Recorder/Archivist is better suited to two people.

Do we have a job description for an Archivist? We do, it is combined with the Recorder job description. Do we need to create a new position of Archivist for the 2024-25 year?

It was suggested that we listen to the new co-Recorders/Archivists as they navigate these issues over the next months.

We ask that the Stewardship Committee:

- 1. Support the co- Recorders/Archivists in cleaning up the files they inherited
- 2. Discern the need for a task force as recommended by the Meeting to address issues concerning the management of the paper and digital archives.

The development of a position of Archivist will continue to be under discernment for the future.

We understand that this may take some time.

# **ADVICES and QUERIES: FIRST MONTH - PEACE**

#### Second Month Queries: Spiritual Life

The life of the spirit gains depth and vigor through devotional practices, prayer, study, and meditation. Take time regularly for individual and family worship, discussions, readings from sacred texts, and other spiritual refreshment to live a more centered life and to bring a deeper presence to the Meeting for Worship.

Friends believe that the spiritual path is best found in community. Create opportunities in your Meetings for people of all ages to explore and express their evolving relationship with the Divine, their spiritual highs and their doubts. If different metaphors and language interfere with communication, listen more deeply, honoring the Spirit in which the thought and words have their beginnings. Do I live in thankful awareness of God's constant presence in my life?

Am I sensitive and obedient to the leadings of the Holy Spirit?

When do I take time for contemplation and spiritual refreshment?

What steps am I taking to center my life and to stay open to continuing revelation?

Do we share our spiritual lives with others in the Meeting, seeking to know one another in that which is eternal?

Does the Meeting provide religious education including study of the Bible and Friends' history and practices?



# Nisenan Land Acknowledgment

We acknowledge the Nisenan people are still here among us today, though they are nearly invisible, and their story continues to be excluded from history.

We understand we are on Nisenan land that was never ceded, and the original tribal families have yet to recover from the near genocide of their people.

As a resident or visitor in Nisenan land, we support the Nevada City Rancheria Nisenan tribe in efforts to stabilize their people as well as the campaign to restore tribal sovereignty through federal recognition.

# **Quaker Call to Support Homeland Return to the Nevada City**

Rancheria Nisenan Tribe to be sent to every Friends Meeting Clerk in the United States.

Dear Friends,

This email, sent on behalf of the Santa Cruz Friends Meeting, is a call to all Quaker Meetings in the U.S. to participate spiritually and financially in an historic Quaker moment: <u>Homeland Return</u> of the Sierra Friends Center (Woolman) to the Nevada City Rancheria Nisenan Tribe.

The board of the Sierra Friends Center (formally, College Park Friends Educational Association, CPFEA) has entered into a purchase agreement with the Nevada City Rancheria Nisenan Tribe through the Tribally-led California nonprofit, <u>California Heritage: Indigenous Research Program (CHIRP)</u>. The Tribe has not had land since 1964 when the Federal Government illegally terminated the Nevada City Rancheria Nisenan Tribe and sold their reservation at auction. This is the Tribe's best opportunity to re-establish a tribal homeland and may support their efforts toward Federal re-recognition.

The land that Sierra Friends Center has operated from is the site of an ancestral Nisenan village called Yulića. These 232 acres, as well as the surrounding land known as "Nevada City, California", were taken from Indigenous peoples during the Gold Rush and sold to settlers who were colonizing the area. A group of Quakers purchased the land in the 1960s for educational programs.

The Sierra Friends Center nonprofit, originally under the care of College Park Quarterly Meeting, was created to operate the school programs and manage the property. The Center ran the John Woolman boarding school, which operated from 1963-2001, followed by the Woolman Semester school, which operated from 2004-2016. The Center also operated outdoor education programs as well as a summer camp rooted in Quaker faith and practice.

The Sierra Friends Center board's journey is chronicled in detail on the <u>Woolman at Sierra Friends Center</u> <u>website</u>. The Tribe now has a time-limited opportunity to purchase the property. The agreed-upon price includes the purchase price, government-mandated improvements, and an operating endowment. The overall fundraising goal is \$2.4 million; the first phase of this effort, to raise \$1.5 million, closes on April 4, 2024. CHIRP launched a <u>GoFundMe campaign</u> at the end of January, which has already reached \$166,000 with over 850 individual donors, including Quakers.

# As Quakers, we believe that supporting this process both spiritually and financially is a living example of our Stewardship testimony and our legacy as activists. It is our faith in action. It creates healing from a moment of loss. It is restorative and it is ethical. It feels important to do all we can to support the Tribe.

At our Second Month Meeting for Worship for the Purpose of Business, the Santa Cruz Friends Meeting passed a minute of support. By encouraging Friends to donate and specifically to identify themselves as Quakers along with their Meeting affiliation, we are broadcasting our support as a faith community. Our Meeting is inviting Meetings across the country to spiritually and financially support this effort. The minute we passed reads as follows:

**Santa Cruz Friends Meeting Minute #2 2-11-24:** Santa Cruz Friends Meeting supports a \$500 donation from the Donations Fund to the California Heritage: Indigenous Research Program (CHIRP), the nonprofit raising funds to purchase the Sierra Friends Center to return the land to the Nevada City Rancheria Nisenan Tribe. [To date, Santa Cruz Friends Meeting and members and attenders have donated \$2000.] SCFM also encourages individuals to make donations "on behalf of the Santa Cruz Friends Meeting". The clerks and Hans Brinker and Nancy Wood will contact other Meetings and publications with this information.

We invite your Meeting to consider this appeal, create a minute of support, make a donation that reflects the significance of this moment, and encourage your members and attenders to donate on behalf of your Meeting as well. Imagine what we can do when we do it in community!

# Honoring Black History Month: Frederick Douglas reminds us

On July 5, 1852, Frederick Douglass was invited to address citizens of his hometown, Rochester, NY, in commemoration of Independence Day. In words both poignant and piercing, he enlarged the hearts and minds of his hearers. In part,


"Fellow Citizens, I am not wanting in respect for the fathers of this republic. The signers of the Declaration of Independence were brave men...They were statesmen, patriots and heroes, and for the good they did, and the principles they contended for, I will unite with you to honor their memory...Fellow-citizens, pardon me, allow me to ask, why am I called upon to speak here to-day? What have I, or those I represent, to do with your national independence? Are the great principles of political freedom and of natural justice, embodied in that Declaration of Independence, extended to us?"

"What, to the American slave, is your Fourth of July? I answer: a day that reveals to him, more than all other days in the year, the gross injustice and cruelty to which he is the constant victim. To him, your celebration is a

sham; your boasted liberty, an unholy license; your national greatness, swelling vanity; your sounds of rejoicing are empty and heartless; your denunciations of tyrants, brass fronted impudence; your shouts of liberty and equality, hollow mockery; your prayers and hymns, your sermons and thanksgivings, with all your religious parade, and solemnity, are, to him, mere bombast, fraud, deception, impiety, and hypocrisy—a thin veil to cover up crimes which would disgrace a nation of savages. There is not a nation on the earth guilty of practices more shocking and bloody than are the people of these United States, at this very hour."

"Americans! your republican politics, not less than your republican religion, are flagrantly inconsistent. You boast of your love of liberty, your superior civilization, and your pure Christianity, while the whole political power of the nation (as embodied in the two great political parties) is solemnly pledged to support and perpetuate the enslavement of three millions of your countrymen...You are all on fire at the mention of liberty for France or for Ireland; but are as cold as an iceberg at the thought of liberty for the enslaved of America."

#### **Sharing Tools for Our Times**

I'll not ask for other blessings, I'm already blessed enough. And may I never be too busy, to help others bear their loads.


