We met on Zoom with a group present in the meetinghouse (hybrid trial meeting)

Present: Don McCormick and Anita McCormick (outgoing clerks), Dean and Karen Olson (incoming clerks), Gordon Starr, Hayley Wilson, Dorothy Henderson, Doug Hamm, Crystal Scanlon, Amy Cooke, Reed Hamilton, Judy Hamilton, Dianne Marshall, Fosten Wilson, Kathy McCreery, Chamba Cooke.

The Meeting opened with silent worship.

The outgoing clerks, Anita and Don, gave the following remark:

Action Items and Seasoning:

MINUTE 2021.10.01: Dean Olson and Karen Olson will serve as co-clerks for Grass Valley Friends Meeting for the 2021-22 year.

COMMITTEE REPORTS (see reports appended, committee clerk is noted in bold)

**STEWARDSHIP:** Mary Starr, Gordon Starr, Reed Hamilton, Pat Phillips, Doug Hamm, Fosten Wilson (Treasurer, Ex-officio) Dianne Marshall (ex officio as Librarian and Newsletter Editor), Hailey Wilson. Gordon Starr gave the report verbally. The committee has discussed when the Meeting will begin to pay the monthly rent at Sierra Friends Center. The SFC has allowed the Meeting use of the meetinghouse today for the trial hybrid meeting. There are some tasks that need to be done in order to settle into the meetinghouse (unpacking the container, for example). They have also discussed the signers on the bank account - both of the current signers are absent from the physical location.

fosten wilson reported that a letter will be brought forward in November to take to the bank naming the treasurer, co-clerks, and clerk of Stewardship as signers on the bank account. fosten gave the Treasurer's Report, page 7.

Minute 2021.10.02: Grass Valley Friends Meeting approves the 2021-22 budget as appended to these minutes.

Meeting has not approved moving back into the meetinghouse yet. It is recommended by the committee that we move back into the meetinghouse. The committee recommends that we move back into the meetinghouse on November 1.

The meetinghouse is still under construction, and the rental agreement has not come forward to the meeting for consideration. The Children's Committee and the Hybrid Committee also have concerns. The current rental agreement is in force. Marty proposed that the new rental amount would be \$575 per month. This has not been approved.

We have approved the expenses for the wifi installation and monthly service. We approved a one time expense of \$225 and the monthly service of \$25. If that is changed we will need to come back to Meeting.

We agreed to hear the reports from the rest of the meeting before considering the new rental agreement and timeline for moving back into the Meetinghouse.

Kathy McCreery gave the report and presented the organization of the month, Quaker Center.

QUAKER CENTER

MISSION STATEMENT: Quaker Center seeks to nurture the spiritual growth and faithfulness of Friends and others, while strengthening Quakerism and its witness in the world. We offer programs and personal retreats exemplifying Friends' testimonies of community, integrity, simplicity, peace, and equality. We strive to live in right order with all creation, especially with the redwood forest that sustains us

here in the Santa Cruz mountains.

Quaker Center is located in Ben Lomond which is between San Jose and Santa Cruz on the California coast. Quaker Center offers workshops of interest to Quakers and others once a month. They rent out space for retreats, weddings, and conferences. Their programs have been on line for the past year. They have begun to reopen and hosted a family work camp in August. You can keep in touch via their newsletter or their website for info on live programs. They have a meeting for worship everyday from 7:30 am to 8am on zoom. Every Wednesday at 10am they have worship sharing from a particular reading. This week it is from “Standing By Words” by Wendell Berry. There are hiking trails and a labyrinth on the property. Their website is [Quakercenter.org](http://Quakercenter.org)

CHILDREN’S PROGRAM: Karen Olson, Judy Hamilton, Dorothy Henderson, Gordon Bishop, Anita McCormick, Doug Hamm, Don McCormick

Dorothy Henderson gave the report, attached.

It was noted that hybrid meetings are too difficult for the children’s program. The committee has discussed having both entirely zoom programs and entirely in-person program times. The committee does not know the guidelines needed for in-person children program gatherings. They want to move carefully and they do not want anyone to feel left out. It is a delicate place the committee wants to move forward with care.

Meetinghouse: We returned to discernment about moving back into the meetinghouse. There are many things to consider, including the impacts to the Children's Program. Can we solve these all at once? Should we start in-person meetings in November and solve the problems as they arise, including the Children's Program? Others felt that there are still issues (for example, equipment storage and contact tracing) that need discernment before we make the decision to move back into the meetinghouse. There was gratitude expressed for the ad hoc committee, and for the work they have done and the work that is still needed.

As we experiment with the building, there is a concern that we need to pay rent for the building's use. Are we not able to have trial hybrid meetings unless we pay rent? How can we review the rental agreement and let it season before moving back into the meetinghouse? It was noted that October 17’s meeting will overlap with CPQM. On October 24 we could do a hybrid, and then October 31 is a Family Meeting. The communication is that we had permission for one hybrid meeting without paying rent. If we have another hybrid meeting, then we may have to pay rent or a use fee. If we use the meetinghouse, we should expect to have to pay for it.

What needs to come to the Meeting for Business regarding the rental agreement? The agreement has been altered a few times over the months of Covid and after the fire. There was discussion about how to remunerate SFC and have clarity about the agreement we have with them. Do we need liability insurance before we begin meeting in person again?

We ask that the Stewardship Committee, Children’s Program committee, Spirit and Witness committee and the ad hoc Hybrid Committee continue to gain clarity on the issues that have been raised and bring back a report to the November Meeting for Business. It was suggested that the ad hoc Hybrid committee make an appointment with a representative from Sierra Friends Center to resolve the questions that have been raised. Do we pay a day rate for the meetinghouse in the meantime? This was delegated to the ad hoc committee.

## **ADVICES and QUERIES: TENTH Month ~ Personal Relationships**

In daily relationships with others, both inside and outside the home, our lives as Friends speak immediately and lastingly. In these relationships, our faith may also be severely tested. We are called to respond to that of God in

everyone: we are all children of God. Friends celebrate any union that is dedicated to mutual love and respect, regardless of the unique make-up of the family. We strive to create homes where the Spirit of the Divine resides at the center and where the individual genius of each member is respected and nurtured.

Human sexuality is a divine gift, forming part of the complex union of body, mind and spirit that is our humanity. In a loving adult relationship in a context of mutual responsibility, sexuality brings delight, fulfillment and celebration.

The presence of children carries a special blessing as well as responsibility. Children bring unique spiritual gifts — wonder, resiliency, playfulness and more. Recognize and honor the Divine Light within children and treat them with the dignity and respect that is due to all people. Listen to and learn from children; share with them those values and practices that are central to our own lives. Special care must be given to resolving problems between adults and children in a manner that gives equal weight to the feelings and needs of both children and adults. Tender parenting is one of the critically important peace vocations in our society. Make every effort to offer all parents the personal and institutional support that this challenging work requires.

Take a strong stand against any form of abuse, whether that abuse is minor or severe, and whether it is emotional, physical or sexual in nature. The terrible impact of abuse on the most vulnerable members of our families creates lifelong suffering for its victims and is a major source of violence in our society. Perpetrators are themselves usually victims of similar violence and should be approached with compassion as well as firmness.

- Do I make my home a place of friendliness, joy, and peace, where residents and visitors feel God's presence?
- Are my sexual practices consistent with my spiritual beliefs and free of manipulation and exploitation?
- What barriers keep me from responding openly and lovingly to each person?
- *Do we open our thoughts, beliefs, and deep understandings to our children and others who share our lives and our hospitality?*
- *Do we provide our children and young adults with a framework for active, ongoing participation in the Meeting?*

**Treasurer's Report for all of FY 2020 – 2021 given October 10, 2021**

summary = Strange year, good enough financially.

With our budget set much lower for the year, we did well. Inbound contributions were lower than when we met in-person, as expected. Yet those contributions were more than we needed, especially after we stopped paying rent in January while the Meeting House was renovated. And our outbound donations have been paid in full. **THANK YOU all for your contributions.**

So, our income (\$11,454) exceeded our spending (\$7,171). Altogether we ended the fiscal year with more in the bank than we had on October first of last year. Whew, a sigh of gratitude.

Now, as we restart meeting in-person we will also return to paying rent to Sierra Friends Center. Our costs will rise. The Stewardship Committee is meeting each month and watching the balance between our spending & income.

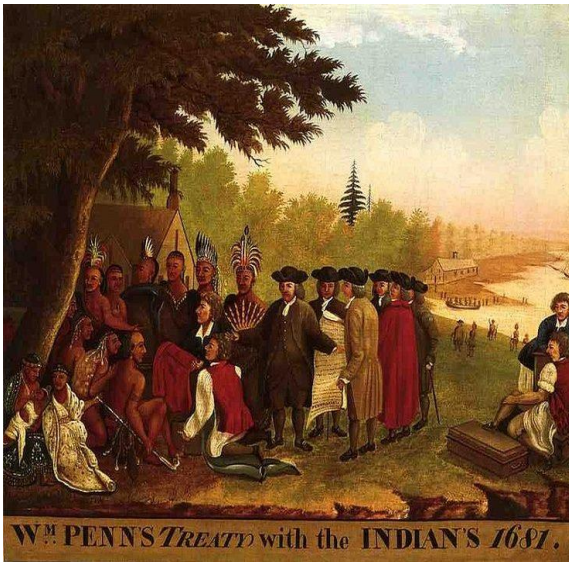


## **New York**

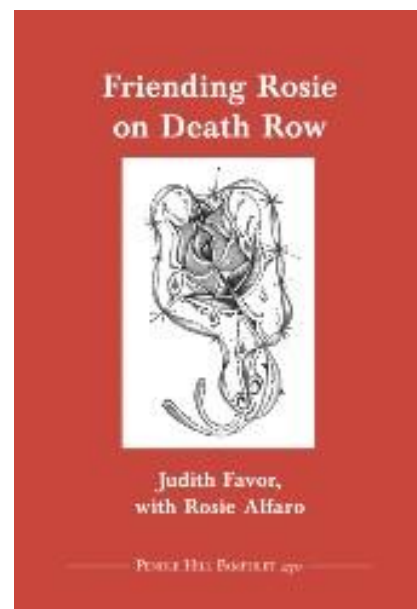
Though virtually forgotten today, this act of brutality set into motion a remarkable series of criminal investigations and cross-cultural negotiations that challenged the definition of justice in early America.
