MINUTES & RECORD: Meeting for Worship on the Occasion of Business July 11, 2021

We met on Zoom.

Present: Don McCormick (co-clerk), Amy Cooke (recording clerk), Dean Olson, Dianne Marshall, Gordon Starr, Doug Hamm, Judy Hamilton, Chamba Cooke.

The Meeting opened with silent worship.

CLERK'S REMARKS

- The purpose of our meetings for business is to seek the Spirit's will for us as a community. We are here to worship and not to get through an agenda.
- If you want to suggest that we take some time for worship or take more time between speakers, please say, "Clerk, can we have some time for silence" or use the Time Out sign.
- Being a clerk is a role assigned to one or two people, but clerking is a bunch of behaviors that we all can engage in, and I hope we all will.
- We leave room for Spirit to come through, releasing our thoughts, judgements, opinions and becoming silent inside and out. We can hand our issues to Spirit/God/Jesus, and then settle into any sensations or messages coming through.

QUERY: How do you know when you've detected the will of the Spirit--in Business Meeting and in your daily life?

- Does something spontaneously occur to you and the thing that lets you know that it's genuine is that it is **NOT** coming from your ego, **NOT** promoting conflict, **not** coming from your intellect, **NOT** a response to something else that was said, and so on? And it is **NOT** all that, and it still stands, you know it is the will of the Spirit.

- Or is there a sense that comes with it that lets you know—a certain feeling (like quaking or feeling compelled to do something even if you really don't want to), an image that accompanies it, or is it the way it sounds inside your head?
- Or is there a sense that it's right, or that it diminishes your ego and your will and you know this because it goes against the agenda or opinion you came into the meeting with?
- Or do you detect something and you think about and evaluate it? You ask yourself, does it promote community, love, or balance? Does it foster joy?

Friends spoke to how they discern the will of the Spirit in their lives and in Meeting.

Co-Clerk's Announcement

Anita McCormick, one of our co-clerks, wrote a letter to our Meeting, which was read and appended.

Don McCormick let the gathered Friends know that he also needs to step down as co-clerk. He shares many of Anita's concerns, and noted that a decision by people who are married is not an individual decision, it is a joint decision. Exposure to one is essentially exposure to both. He accepted the position as co-clerk because it was a joint position. He let us know that he could not and cannot do the work on his own. In addition, he has been working on a year-long mindfulness teacher training program and it is much more work than he had anticipated. Our co-clerk is overwhelmed. He also communicated to us that he has gotten a lot out of being co-clerk. He has learned a lot. It is good work that he has valued and he will miss it.

STEWARDSHIP: **Mary Starr**, Gordon Starr, Reed Hamilton, Pat Phillips, Doug Hamm, Fosten Wilson (Treasurer, Ex-officio) Dianne Marshall (ex officio as Librarian and Newsletter Editor), Hailey Wilson

Gordon Starr gave the report, attached.

There was a meeting with Marty, who has reaffirmed the importance to Sierra Friends Center of the Grass Valley Friends Meeting. She also confirmed that the Meetinghouse and the classroom are the sole use of GVFM from 9 am to 2 pm on Sundays. She is also interested in acquiring the equipment for blended or hybrid meetings. We are also free to purchase that equipment ourselves. Marty also spoke to the experiences Friends had when the memorial for Peggy took place. She noted that all group activities need to adhere to new cleanliness guidelines as well as insurance needs. The Center is also contending with having to closely monitor who is on campus.

We need to hold our own insurance for liability. It was noted that Church Mutual dropped Sierra Friends Center after the fire. State Farm has made some recommendations. Mertens Insurance, and Wanda Mertens specifically, was recommended.

Work days will still be available by prior arrangement. We must clean up after ourselves. Also, they will be making the meetinghouse shoes-free, with an entry area for shoe storage. The floor will need to be cleaned after each use. SFC will supply cleaning supplies and directions.

The Stewardship Committee is recommending that we pay half of the wifi installation cost (\$225) as well as start paying \$25 per month for the wifi service. The timing is unclear at this time.

MINUTE 07.2021.01: Grass Valley Friends Meeting accepts the Letter of Sojourn for Amy Cooke and Chamba Cooke to the Groupe Languedoc in Congenies, France as attached to these minutes.

MINUTE 07.2021.02: Grass Valley Friends Meeting approves the new Representative structure as attached to the June 2021 Minutes of the Meeting for Business.

MINUTE (seasoning until 9th month): Grass Valley Friends Meeting warmly welcomes Judy Hamilton to the Grass Valley Friends Meeting of the Religious Society of Friends.

The Memorial Minute for Peggy Baldwin was read and accepted.

Hybrid Meeting ad hoc Committee: Gordon Starr, Amy Cooke, Don McCormick, Pat Phillips.

The committee met and did not come to unity. We would like to hear how Friends are feeling, what their thoughts are, and gather input and feedback.

The issues that the committee grappled with were:

1. Re-opening guidelines (indoor vs outdoor, masks, contact tracing, COVID testing if symptoms are present, Delta variant risks)
2. Equipment issues (What do we need? What equipment will Sierra Friends Center buy? Who will be in charge of set up and operation?)
3. Wireless Configuration and costs
4. Move-in date to communicate to Sierra Friends Center

The attached report was read by Gordon Starr and a mini threshing session was convened on the topic, with the following comments:

- It was noted that the Children's Program has decided not to meet in a hybrid fashion.
- How will we handle singing given that singing is a highly contagious activity?
- There are people who do not show up because Zoom does not work for them. How can we get their input given that they do not meet on Zoom?
- Could we meet at a greater distance for singing?
- An example was mentioned of an outbreak at a place of work at which all persons there were vaccinated.
- The number of cases is increasing drastically. It is unclear whether that is due to opening up or to the Delta variant.
 - New cases are largely in younger populations and in unvaccinated individuals.
 - There was concern about our relationship with Sierra Friends Center. There was discomfort expressed with taking our time with this decision.
 - Can we meet with those people who are comfortable with in-person meetings and include those who are uncomfortable on Zoom?
 - If we decide not to meet at Sierra Friends Center, can we reach out to those who do not meet on Zoom?

- As we discern God's will, science and policy is one part and not the only part.
- Given the long-standing relationship with SFC, we have a certain amount of interest in meeting in person if possible and work with Zoom to improve the experience in order to meet the needs of those who are not able to participate in person. We are in process.
- We can honor those who are evaluating the risk and making the judgement that they cannot participate in person. And, if those who feel comfortable meeting in person are willing to do so, then we can also honor that.
- There is support for reaching out to as many people as we possibly can in as many ways as we can. Friends volunteered to help in that effort (Dianne Marshall and Judy Hamilton).
- It was also noted that there is evidence that you can test positive if you are vaccinated and not transmit the virus.

This issue will now go back to Spirit and Witness for the next steps. We recommended that the newsletter, phone calls, and email tree be used to gather information. S&W will meet in August. The Newsletter editor noted that the August newsletter could be a single subject issue.

Grass Valley Friends Meeting Quarterly Treasurer's Report, 7-7-2021

summary = Mixed . . . ok for now.

Contributions were excellent in April, but May & June were thin*. Overall, contributions have exceeded our budget expectations since October. Income is down a lot since Covid-19 stopped our in-person Meetings. But our costs dropped with our reduced budget & when we stopped paying Meetinghouse rent and started renting the cargo container in January.

With more income than expenses, we have been able to pay PYM, CPQM, & *all of our outbound donations* for this fiscal year, by June 30th. Costs will increase when we resume Meeting for Worship in person.

All Restricted Funds (Sharing Fund, Scholarship Funds, etc.) are unchanged in the last three months. Our General Fund includes container rent, our donation to the Neisenan, and our costs for the Peggy Baldwin memorial along with the items mentioned above.

New Quaker Communities

How do Quakers build strong, limber communities? How do we become relevant in 2050? I believe to answer these questions we need input from people across many different ages and lifestyles.



Johanna Jackson (she) is a member of State College Friends Meeting. She travels in the ministry with JT Dorr-Bremme, a Friend with a gift for eldering. They formed the [Listening Project](#), a series of creative conversations rooted in love. Johanna writes about the spiritual community that sustains her, imagining how similar groups could help sustain others, too.

JOHANNA JACKSON: I am part of the [Tuesday Worship Group](#), a peer support network that spans across several yearly meetings. We are all Friends ages 20-50. We work to support faithfulness with weekly worship-sharing. I believe that what we are doing is a new model among Friends. Our combination of worship-sharing and companionship may work for others, too.

The Tuesday Worship Group is small in number (4-6 Friends), yet we offer great richness to one another. We first tested out remote worship in November 2018, unsure if we would like it. In meeting, though, we found the courage and companionship that we needed. We decided to start meeting weekly in March 2019.

Later, two members of the group began to wonder if the barriers we'd faced in the Quaker world were happening to other people as well. JT and I started holding worship-sharing with many other Friends, mostly listening, and formed the [Listening Project](#) in 2020. The Listening Project is a series of creative conversations, rooted in love. From these interviews, we have learned much about the spiritual condition of Friends. What we had long suspected is true: many Friends under 55 are in need of spiritual peers. How do we help build community for younger Friends? [Here's a to-do list.](#)

1. Find Spiritual Peers

I helped form this worship group because I needed peers on my journey. I was exploring new spiritual ground and had mentors, but no peers. My local meeting deemed "medium to large" by Quaker standards, did not include anyone within ten years of my age. I continued like this for seven years. Then I met spiritual peers at the FGC Gathering in 2017. How revitalizing!

We need large gatherings like FGC to help people find their age-mates and travel mates. In our case, the Tuesday Worship Group was spread out across a wide distance. When we first started meeting, the average drive time between two houses was five hours. Some individual pairs lived closer than that, but it was rare. We spanned across four yearly meetings, but had only five members! That's how far we needed to reach to find a core group. Offering scholarships to attend large gatherings, either individually or systemically, supports the future of the Religious Society of Friends.

2. Create Small Groups

In the past, as recently as the 1970s, Quakers enjoyed a boom of young people who supported and encouraged each other. Brian Drayton ([On Living with a Concern for Gospel Ministry](#)) talks about coming into spiritual maturity with a circle of other elders and ministers. Quakers I know, now in their 60s, recall potlucks and conversations with peers when they were in their 30s. As our numbers decline, younger Friends today need to reach beyond their local meetings to find that community of peers.

Small groups can help. We need new structures and alternatives to support Friends under 55. These include worship-sharing groups and networks, which can foster leadership in a new generation. The Tuesday Worship Group is one such group, but there are many models. The [Three Rivers Meeting](#) is a remote worship group. It focuses on reclaiming and reinventing Quaker practices for today. Other groups include [spiritual friendship circles](#) and a set of peer support groups recently sponsored by New York Yearly Meeting. We have an opportunity to intentionally build groups like these.
